

## **CROSS CREEK COUNTRY CLUB**

### **POOL AND POOL AREA RULES**

**RULES AT THE POOL ARE INTENDED TO HELP PROVIDE A SAFE AND ENJOYABLE ENVIRONMENT FOR OUR MEMBERS, GUESTS AND STAFF. SAFETY IS ALWAYS PARAMOUNT AT CROSS CREEK COUNTRY CLUB.**

1. RULE # 1 - HAVE FUN!!!
2. LOUNGE CHAIRS AND TABLES CANNOT BE RESERVED
3. USE OF THE SWIMMING POOL AND POOL AREA IS RESTRICTED TO MEMBERS, THEIR IMMEDIATE FAMILIES AND REGISTERED GUESTS. EVERYONE USING THE POOL MUST CHECK-IN PRIOR TO USING THE POOL AND POOL AREA.
4. ALL MEMBERS BRINGING A GUEST MUST PAY THE \$5.00 PER DAY GUEST FEE, BILLED TO THEIR MEMBER ACCOUNT. GUESTS WHO DO NOT REGISTER WILL BE ASKED TO LEAVE THE AREA. PERSISTENT ABUSE WILL LEAD TO SUSPENSION OF POOL PRIVILEGES.
5. ALL SWIMMERS MUST SHOWER BEFORE ENTERING THE POOL.
6. NANNY RULE: A GUEST FEE IS NOT REQUIRED FOR AN APPROVED, NON-MEMBER BABY SITTER WHO IS WORKING AND WATCHING UNDERAGE CHILDREN.
7. INFANTS WEARING DIAPERS MUST WEAR POOL APPROVED DIAPERS. ANY "BABY ACCIDENTS" REQUIRING THE CLUB TO CLOSE, CLEAR AND SHOCK THE POOL WILL RESULT IN A \$250 FEE TO THE OFFENDING MEMBER.
8. RUNNING, PUSHING, AND BOISTEROUS PLAY IS STRICTLY FORBIDDEN. PROFANITY OF ANY KIND WILL NOT BE TOLERATED.
9. LIFE GUARDS HAVE FULL AUTHORITY TO ENFORCE ALL CLUB RULES AS WELL AS SIT-OUT AND/OR BAN ANYONE WHO REFUSES TO ABIDE BY THE RULES. ANY LIFEGUARD COMPLAINTS MUST BE DIRECTED TO THE GENERAL MANAGER.
10. RAFTS, KICKBOARDS OR OTHER LARGE FLOATING DEVICES THAT HINDERS THE LIFEGUARD FROM SEEING THE BOTTOM OF THE POOL ARE PROHIBITED. THE THROWING OF BALLS IN THE POOL AREA IS ONLY PERMITTED IF THE ACTIVITY DOES NOT INTERFERE WITH OTHER SWIMMERS.
11. GLASS CONTAINERS ARE NOT PERMITTED IN THE POOL AREA
12. PETS ARE FORBIDDEN IN THE POOL OR POOL AREA UNLESS THEY ARE WORKING DOGS
13. ALL POOL PATRONS MUST WEAR PROPER BATHING ATTIRE IN THE POOL AND POOL AREA. CUT OFF JEANS ARE NOT CONSIDERED PROPER BATHING ATTIRE.
14. ALL PATRONS USING THE DIVING BOARD MUST USE SAFE DIVING BOARD PRACTICES. ONLY ONE PERSON AT A TIME IS PERMITTED ON THE DIVING BOARD. THE LANDING AREA MUST BE CLEAR BEFORE THE NEXT PERSON CAN DIVE, ETC.
15. THE POOL MAY ONLY BE USED DURING SCHEDULED HOURS AS POSTED UNLESS OTHERWISE APPROVED BY MANAGEMENT.
16. NO ONE SHALL USE THE POOL IF THEY HAVE ANY INFECTIOUS OR CONTAGIOUS DISEASES (IE. BAD COLD, POISON IVY, OPEN WOUNDS, ETC)
17. SMOKING IS NOT PERMITTED IN THE POOL AREA
18. ADULT SWIM MAY BE CALLED BY THE LIFEGUARD DURING THE FIRST 10 MINUTES OF EVERY HOUR. ALL CHILDREN SHALL VACATE THE POOL DURING THIS TIME.
19. MEMBERS ARE EXPECTED TO PLACE ALL THEIR TRASH IN WASTE CONTAINERS

20. LIFE GUARDS ARE EMPLOYED TO BE FIRST RESPONDERS IN THE CASE OF AN ACCIDENT AND TO PROVIDE A SAFE SWIMMING ENVIRONMENT. LIFE GUARDS ARE NOT BABYSITTERS OR DISCIPLINARIANS AND ARE NOT PERMITTED TO HAVE CASUAL CONVERSATIONS WITH POOL PATRONS WHILE ON DUTY.
21. LOITERING IN THE RESTROOMS IS PROHIBITED
22. NO CHILDREN OVER THE AGE OF 6 ARE PERMITTED IN THE BABY POOL
23. A LAP LANE WILL BE PROVIDED UPON REQUEST AND SHALL BE USED SOLELY FOR LAP SWIMMING.
24. CHILDREN 12 – 15 MAY BE AT THE POOL WITHOUT ADULT SUPERVISION AFTER PASSING THE SWIM TEST, WHICH INCLUDES SWIMMING THE LENGTH OF THE POOL TWICE, IN FIVE MINUTES, WITHOUT ASSISTANCE AND HAVING A COMPLETED UNACCOMPANIED INFORMATION AND AUTHORIZATION FORM ON FILE AT THE CLUB.
25. LIFEGUARDS MAY USE THEIR OWN, REASONABLE DISCRETION AND JUDGMENT TO PROVIDE A SAFE AND RESPECTFUL POOL ENVIRONMENT
26. THE POOL MAY BE CLOSED AT THE DISCRETION OF CLUB STAFF DUE TO INCLEMENT WEATHER OR SAFETY. EVERY ATTEMPT WILL BE MADE TO RE-OPEN THE POOL IF IT IS REASONABLE TO DO SO.
27. THE CLUB IS NOT RESPONSIBLE FOR DAMAGES, LOSS OF PERSONAL PROPERTY OR ANY INJURIES

#### **ADDITIONAL INFORMATION**

- LIFE GUARDS MAY ON OCCASION PERFORM POOL CLEARING DRILLS. 3, SHORT, WHISTLE BLASTS WILL INDICATE THE NEED TO CLEAR THE POOL ALONG WITH “GET OUT OF THE POOL” INSTRUCTIONS. ONE LONG WHISTLE BLOW WILL INDICATE THE ALL CLEAR. A POOL CLEARING DRILL MAY BE USED TO RESTORE ORDER IF A GUARD FEELS THAT A GROUP GAME IS BECOMING UNSAFE.
- LIFE GUARDS WILL BE RESPONSIBLE FOR THE DAILY CLEANING OF THE POOL. VACUUMING AND SWEEPING OF THE POOL MAY, ON OCCASION, BE DONE WHEN SOME PEOPLE ARE SWIMMING. LIFE GUARDS ARE INSTRUCTED TO NOT VACUUM THE POOL WHEN IT IS BUSY (MORE THAN 8 PEOPLE)
- THE POOL AND POOL AREA MAY BE RESERVED FOR PRIVATE PARTIES AFTER 6:00PM. THE EARLY CLOSING OF THE POOL FOR A PRIVATE PARTY WILL BE COMMUNICATED TO MEMBERS VIA EMAIL AND POSTED SIGNAGE AT LEAST 3 DAYS PRIOR TO THE EVENT. A FACILITY FEE, GUARD FEE AND MINIMUM FOOD AND BEVERAGE SALES WILL BE CHARGED.
- MEMBERS BRINGING LARGE GROUPS TO THE POOL (10 OR MORE) MUST CALL THE CLUB AT LEAST 24 HOURS AHEAD AND PAY THE APPROPRIATE GUEST FEES. ADDITIONAL GUARD FEES MAY BE REQUIRED FOR LARGE PARTIES.
- THE LIFEGUARD HAS FULL AUTHORITY AND MAY CLOSE THE POOL AND/OR DIVING BOARD UNDER CERTAIN, UNSAFE CONDITIONS.
- THE CROSS CREEK COUNTRY CLUB POOL IS OPEN FROM 11:00AM TO 7:00PM 6 DAYS A WEEK AND FROM 1:00PM TO 7:00 ON SUNDAYS. MEMORIAL DAY TO LABOR DAY
