# Membership Options

Cross Creek offers several membership levels to accommodate a variety of budgets and household needs. Our 18-hole championship golf course features 68 strategically placed bunkers, seven bodies of water, and multiple creeks — providing challenges for golfers of all skill levels. The course spans approximately 6,800 yards and plays to a par 72.

## Membership Policies

- **All memberships are annual. Seasonal memberships for the pool or golf are not available.**
- **Memberships that are dropped are eligible for reinstatement 12 months from the drop date.**
- **The Individual Membership is limited to a single-person household, with no exceptions.**

# Men's Golf Association

All golf members at Cross Creek are eligible and encouraged to participate in the Men's Golf Association. The MGA meets on the second Tuesday of every month at 6:00 PM, with no meeting held in December, and annual dues are \$50 collected through the club.

These funds are designated exclusively by the MGA for products and projects that directly benefit the Cross Creek golf course. By paying dues and attending meetings, members have a voice in how those funds are put to use.

We are proud of and grateful for our MGA and the lasting impact they have made on the Cross Creek golf course. Over the years, their contributions have funded a wide range of projects and upgrades, including sand and rakes for the bunkers, flags, the fountain on the 18th hole pond, two pull-behind aerators for the fairways, and numerous landscaping projects — among many other improvements.

The MGA also works closely with our Golf Professional to plan and execute tournaments throughout the year. Please note that all tournament participants are required to have an official GHIN handicap. Any player without one will be assigned a handicap of 2. Additionally, the Pro Shop will conduct random checks of the GHIN system to ensure that all Cross Creek MGA members are posting scores for every round played. Rounds that are not posted may be assigned a score of 72.

## **Annual Tournaments:**

**Breakfast Scramble:** Season kickoff in April with both men and ladies invited to join this one day, scramble format tournament

**Spring Ringer:** Also in April, this two day weekend tournament is open to members and guests

**Member Member:** Always in June, this two day weekend tournament is comprised of two man teams made up of members only

**Member Guest:** The first weekend in August every year, this two day weekend tournament is comprised of two man teams made up of one member and their selected guest

**Senior Tournament:** Typically in October on a Tuesday, this Seniors only is a one day fun event

**Tough Day:** This one day tournament in October is brings a lot of laughs

**Club Champion:** Winning this earns your bragging rights AND premiere designated parking space for the year. There are lots of ways to accumulate points all year long for this tournament.

The clinics will cover the basics; chipping, putting, full-swing, sand play, and a lesson on golf course etiquette.

The season kicks off with the annual Par-Tee in March. The LGA hosts a super fun and relaxed Couples Tournament in the fall. Don't miss out!

Members of the LGA can participate in many tournaments each season. A schedule will be posted on this webpage as soon as it is available. Cross Creek Country Club offers an eighteen-hole Championship golf course designed by Joseph Lee. Lee's par 72 design was recently renovated and now features A-1 and A-4 blend of lush bent grass greens and has been an integral part of the Mount Airy community for 40 years.

The course plays 6,800 yards from the championship tees and is located at the base of the Blue Ridge Mountains. First opened in 1973, Cross Creek Country Club is founded on a tradition of championship golf.

# Member Events

## General

Membership privileges are extended to the account's named member, their spouse, member's unmarried children and step-children under the age of 23 who are residing in the member's household or who are away attending school.

We do not allow dogs in the clubhouse unless they are Certified Service Dogs.

Member payments are due in full by the 15<sup>th</sup> day of the calendar month in which the statement of account is mailed.

To avoid possible hazardous conditions or personal injury, **there is no fishing during golf hours.**

*Fishing is permitted for Members Only (or Annual Pass Holders) on the golf course after dusk when golf has ended for the day. There is no fishing in the pond with the fountain.*

Smoking is not allowed in any area of the clubhouse or by the entrance of any door.

Members introducing new visitors to the Club should be responsible for their conduct in the Clubhouse and on the Club grounds, and for all debts due to the Club which may be incurred by them.

Towels and personal hygiene supplies are stocked in the shower area of the locker rooms for member's convenience.

# Membership Agreement

## PURPOSE AND INTENT

Club Operator owns, operates and manages certain real property and facilities known as Cross Creek Country Club located in Mount Airy, North Carolina. The facilities of the Club presently consist of a 18-hole golf course; an event venue, a swimming pool; 4 tennis courts (2 clay and 2 hard surface); a playground and a clubhouse with food and beverage facilities, locker rooms, a golf shop, and golf club storage facilities (collectively, "Club Facilities").

Member wishes to acquire and Club Operator desires to grant to Member a non-exclusive license to use all or a portion of the Club Facilities as a member of the Club upon payment of such membership fees as Club Operator may establish from time to time. Such license shall be subject to the terms and conditions set forth in this Agreement, the Member's Application for Membership in Cross Creek Country Club ("Application"), the Membership Policies of Cross Creek Country Club, as in effect from time to time ("Membership Policies"), and the Club Rules of Cross Creek Country Club, as in effect from time to time ("Club Rules").

For and in consideration of Member's payment to Club Operator of an initiation fee, and in further consideration of the mutual covenants set forth in this Agreement, Club Operator hereby grants to Member, and Member hereby accepts from Club Operator, membership in the Club on the following terms and conditions:

## TERMS AND CONDITIONS

1. **Class of Membership.** Club Operator hereby grants to Member a \_\_\_\_\_ Membership, constituting a license to use all or a portion of the Club Facilities in accordance with the privileges of such class of membership as set forth in the Membership Policies.
2. **Term of Membership.** The membership shall commence on the later of the date set forth above or the date on which Club Operator approves and accepts Member's Application, as set forth below, and shall continue in effect until terminated as provided in the Membership Policies.

Membership rates, such as dues, golf services, assessments, and food minimums including sales tax as set forth below, shall remain the same without an increase for the Initial month period beginning the date that this contract is signed. At the completion of the \_\_\_\_ month period, the Member will then become responsible for such membership rates that are in effect at that time and as set forth in Member's qualifying category of membership.

Member may voluntarily resign his/her Membership for by providing the Club with a 30-day written notice of such intention. Such resignation shall be effective on the first day of the month following the end of the 30-day period, known as the effective date of resignation. A resigning Member shall continue to be obligated for monthly club fees, services, & other club fees charged and may continue to enjoy the privileges of such Membership through the effective date of such resignation. Dropped/down-graded memberships are eligible to be reinstated after 1 year.



3. **Membership Fees.** Member acknowledges and agrees that the initiation fee for the membership is \_\_\_\_\_ Dollars (\$ \_\_\_\_\_).

Member understands that the membership is subject to payment of the initiation fee set forth above, periodic dues and such other fees and charges as Club Operator may establish pursuant to the Membership Policies (collectively, "Membership Fees"), all of which are subject to change from time to time. Member agrees to be responsible for all charges incurred by Member's authorized users and guests in their use of the Club Facilities.

Member agrees to pay all Membership Fees on or before the due date (last day of each month). Late fees begin accruing the first day of the month following due date. Member understands that delinquency in paying any amounts due will result in late charges of 1.5% per month. Club Operator has the right to suspend or terminate membership in the Club due to nonpayment. Member further agrees that if Member is delinquent in paying any amounts due, Club Operator shall be entitled to recover from Member late charges, interest and all costs and expenses which Club Operator reasonably incurs in attempting to collect the past due amounts, including, without limitation, attorney's fees and court costs, whether or not suit is filed.

4. **Receipt of Club Documents.** By execution below, Member acknowledges receipt of the Membership Policies and the Club Rules and agrees to be bound by and comply fully with the terms and provisions of such documents, as they may be amended, and to be responsible for compliance by Member's family members and guests.

**5. Assumption of Risks and Indemnification.**

(a) In consideration of the membership and as a condition of using the Club Facilities, Member agrees to all risks associated with the use of the Club Facilities, including risks associated with use of or proximity to the golf course (e.g., being hit by a golf ball, struck by lightning, falling), and agrees to release and indemnify Club Operator from and against any and all losses, expenses, liens, claims, demands and causes of action of every kind and character for death, personal injury, property damage or any other liability, damages, fines or penalties, including, without limitation, costs, attorney's fees and settlements, whether or not based on the acts or omissions of Club Operator, resulting from, arising out of or in any way connected with the use of the Club Facilities by Member, Member's family members, guests, approved designees, and their family members and guests. As used in this paragraph, "Club Operator" shall include Cross Creek Country Club, their respective directors, officers, shareholders, partners, members, agents, related companies, affiliates, predecessors, successors, assigns and employees, and all persons, corporations, partnerships and other entities with which they are or may in the future become affiliated. This paragraph shall survive the termination of this Agreement and Member's membership in the Club with respect to any property damage, personal injury or death occurring prior to such termination.

(b) Member, as a condition of the membership, and each of Member's authorized users and guests, as a condition of invitation to use the Club Facilities, assumes sole responsibility for their personal property. Member acknowledges and understands that Club Operator shall not be responsible for any loss or damage to any personal property which Member, Member's family members, guests, approved designees, or their family members or guests may use or store on the Club premises, whether in lockers or elsewhere. Member also acknowledges and understands that Member shall be liable for any property damage or personal injury at the Club, or at any activity or function operated, organized, arranged or sponsored by the Club, which Member, Member's family members, guests, approved designees, or their family members or guests may cause. If Member



arranges or sponsors any activity or function on the Club premises, Member shall be responsible for any such damage or injury even if such damage or injury was not caused by Member. Member agrees that Club Operator may charge the cost of any such damage to Member's Club account.

6. **No Vested Interest.** Member acknowledges that in acquiring a membership, Member acquires only a non-exclusive license to use all or a portion of the Club Facilities, in accordance with this Agreement and the Membership Policies and in common with such other persons, including, without limitation, the general public, as Club Operator may authorize from time to time. Member acknowledges that Member acquires no ownership or vested rights in or to the Club Facilities or Club Operator, and does not have any right to participate in the management or control of Club Operator or the Club Facilities.

7. **Cancellation of Membership.** Membership cancellation must be sent in writing (email or a letter) and 30 days notice is required. Memberships end at the end of a month and the 30 days notice starts at the receipt of the cancellation request. Membership balance MUST BE paid in full in order for a cancellation to be processed. Dues will continue to bill until the balance is paid off.

8. **Transfer and Assignment of Membership.** Member acknowledges that the membership conferred here- under may not be pledged or assigned and is not transferable, unless and except as otherwise specifically set forth in the Membership Policies.

9. Member Agrees to maintain a current email address on file with the club and to regularly check it and the club's website for news and information.

MEMBER ACKNOWLEDGES THAT MEMBER IS ACQUIRING A MEMBERSHIP FOR THE SOLE PURPOSE OF OBTAINING SOCIAL BENEFITS AND RECREATIONAL USE OF THE CLUB FACILITIES AND NOT AS AN INVESTMENT OR WITH ANY EXPECTATION OF MAKING A PROFIT FROM THE OWNERSHIP OR FUTURE TRANSFER OF THE MEMBERSHIP.

**This Agreement shall not be binding unless and until the Member's Application is approved and accepted on behalf of Club Operator as provided therein and this Agreement is executed below by Club Operator.**
